Act. 2.2. Training Modules

Main objective of this Training Module:

The objective of the meeting is to familiarise the attendees with the basic concepts of intellectual property as regards, specifically, the protection of patents, plant varieties, geographical indications and trade marks. We will further consider relevant aspects of traditional knowledge and, as far as university IP management is concerned, fundamental aspects of issues such as ownership, licensing and the law applicable to IP and licensing contracts. We will also include case studies relevant for the partner organisations.

Expected Results:

We expect that the knowledge acquired during the London meeting will be deepened, and that the partners will acquire a more general understanding of how the various concepts of IP and related rights operate. It is important that the partners fully understand the basic structure and differences between these rights and therefore aspects already covered in London will be covered again, with a slightly more specific focus on the operation of the rights in relation to agricultural products.
